**CM APPL.12436/2015 in W.P. (C) 4572/2007 (for directions)**

Having heard the submissions of Ms. Madhu Tewatia, learned counsel for the applicant, Municipal Corporation of Delhi, we find no reason to grant any of the reliefs as prayed for.

The application is accordingly dismissed.

**CM APPL.9309/2015 (Exemption) in W.P. (C) 4572/2007**

Application stands allowed subject to all just exceptions.

**CM APPL.9308/2015 in W.P. (C) 4572/2007**

The application seeks modification of the order of 30<sup>th</sup> April, 2015 by which certain encroachments in the main Chandni Chowk carriage way were directed to be removed in a time bound manner. North Delhi Municipal Corporation relies upon orders of the Principal Secretary (Urban Development) of the GNCTD dated 10.01.2012 and 24.02.2012 to say that the title in the roads now vests with the GNCTD. In terms of Section 298 of the Delhi Municipal Corporation Act, the title in all public streets and roads vests with the concerned Municipal Corporation. In the circumstances, the relief claimed cannot be granted. However, all authorities including the GNCTD are directed to cooperate in the execution of order dated 30<sup>th</sup> April, 2015. A compliance report shall be filed within two months.

The application is disposed off as having become infructuous.
