JAGJIVAN RAM AND SUCH OF YOUR OTHER COLLEAGUES AS YOU MAY LIKE TO HAVE AT AN INFORMAL CONFERENCE

SHOULD YOU DECIDE TO GIVE US A HEARING MODY AND I ARE AT YOUR DISPOSAL ANY TIME YOU WANT US TO COME TO DELHI

TO SAVE TIME MAY I SUGGEST THAT YOUR REPLY BE COMMUNICATED TO ME THROUGH PAN

**STOP** 

I BEG YOU TO BELIEVE THAT I AM MOTIVATED BY NO SELF INTEREST IN THIS MATTER

**STOP** 

MY ONLY ANXIETY IS TO SEE A STRONG AND EFFICIENT INDIAN AIR TRANSPORT SYSTEM BUILT UP AND AT THE SAME TIME TO SEE JUSTICE DONE TO INVESTORS AND STAFF WHO HAVE SUFFERED HEAVILY.
