Subject:- A humble representation for restraining from relocation/ removal of the Mosque near R.C.P.E college with a request for recording of Khas land under the possession of the Mosque as WAKF land under the Revenue Department, Govt. of Tripura.

Respected Madam

In pursuance to the Memorandum vide even No.F.8(26)/SDM/PNS/REV/2018/840 dated 18/01/2021. We the managing committee of the Mosque near RCPE college, beg to draw your kind, gracious attention to look into the matter and soliciting sympathetic consideration.

That, the aforesaid Mosque as well as the Debasthan Temple were constructed by the C.R.P.F Jawans Govt. of India in the year 1982. Thus, the establishment of both the Mosque and Debasthan Temple being the National memoirs since both the shrines have been carrying out the "Unity of Diversity" principles, the basic features of our secular India. Both are the identity of our rich composite culture for more than 38/39 years old, as mentioned in Part IV A (Article 51 A) of our Constitution.

That, at the time of departure, the Muslim CRPF Jawans had handed over the Mosque to the locc's Muslims and the Hindu Jawans dedicated the Debasthan Temple to local Hindu Community respectively. Thus, both the communities have been performing religious activities maintaining absolute peace and tranquility for last 38/39 years where our religious faith, belief, emotions and long practised tradition etc. have been erected/established beyond questions.

That legally, we have acquired Rights by Adverse Possession as per provision of the Indian Limitation Act 1963.

That gradually, the aforesaid Mosque becomes Panisagar Sub-Divisional Jumma Masjid. Muslims who comes from various corner of the sub-division to the SDM and other offices, perform prayer in this Mosque. The same being the one and only Mosque within Panisagar Nagar Panchayat Area. Sometimes Professors and students from RCPE college and BSF Jawans also come to perform prayers/ Namaz etc. in the Mosque.

That, under such a situation issuance of MEMORANDUM for relocation/ removal of the same Mosque is very heart broken and regrettable too. If any order of eviction or removal etc. is executed so that the religious faith, belief and emotion of the Muslim community of whole Panisagar Sub-Division would be told upon to a great extent,
